Local dues are \$175.00; State Association dues are \$140.00. Both are collected on an annual basis. If an applicant has paid State dues through another Local Association, a dues waiver issued through your primary Association is acceptable. Dues are pro-rated on a monthly basis.
4. New members are invited as the Association's guest for an introduction to the membership at our next regularly scheduled membership meeting.
